At the time of commissioning, it was the largest airside solar farm in the UK. It is a 9.7 MWp project with 1.5MW of battery ...

Following this acquisition, AMPYR Solar Europe will have a development pipeline of Solar PV assets of over 1 GWp in the Netherlands, and an aggregate development pipeline of 6 GWp including Germany and UK, moving AMPYR Solar Europe a step closer to its goal of being a leading independent solar power producer in Europe.
