Cenovus projects net offshore production in the range 60,000 to 70,000 boe/d. Cenovus Energy has awarded Harland & Wolff a \$61-million (\$74.24-million) contract to perform a mid-life upgrade on the SeaRose FPSO.

Where is Cenovus oil & natural gas located?

Cenovus once held conventional oil and natural gas operations across Alberta and Saskatchewan, including the Weyburn oilfield in Saskatchewan, which is the largest CO₂ enhanced oil recovery operation in Canada.

Cenovus was created on December 1, 2009 through a corporate reorganization splitting Encana Corporation into two highly focused energy companies: an integrated oil company, Cenovus Energy Inc., and a natural gas company, Encana Corporation. Encana shareholders received one Cenovus common share and one Encana common share for each Encana share held.
