Who owns Elgin energy?

Copenhagen Infrastructure Partners(CIP) has agreed to acquire a majority share in Irish solar developer Elgin Energy. The partnership will see both Copenhagen and Elgin's retained management jointly invest £250m in the solar developer. The division of investment between the two has not been disclosed.

Does Elgin energy have a solar project?

Elgin's current 15GW project pipeline includes stand-alone solar,solar co-located with battery storage and stand-alone battery storage systems in the UK,Irish and Australian markets. The investment in Elgin Energy was made through CIP's flagship fund,CI V.
