How do employees get paid in Mexico?

Salaries in Mexico are paid directly into the employee's bank account. Employees receive a pay slip detailing their earnings, deductions, and net pay. What are the common pay structures in Mexico?

How is payroll tax calculated in Mexico?

A percentage is applied to the company's total payroll. For example, if the state payroll tax is 2% and the company's total payroll is \$100,000 MXN, the tax to be paid would be \$2,000 MXN. The employee's income tax is calculated based on their gross salary and income level, according to the income tax tables established by the Mexican government.

Do employers pay Social Security in Mexico?

Employers in Mexico pay social security on wages and deduct social security contributions from employee paychecks, much the same way companies in the U.S. operate. In Mexico, though, these contributions cover all basic healthcare, so employers do not have to offer their own healthcare plans.

Do employees have to pay taxes in Mexico?

They must also withhold and remit a payroll tax at the state level. **Accrued Vacation and Vacation Bonus:** According to the Federal Labor Law in Mexico, all employees are entitled to a minimum period of paid vacation per year. The number of vacation days may vary depending on the employee's length of service with the employer.

Do Mexican employees get a bonus if they take PTO?

In addition to the time itself, employees in Mexico receive a bonus when they take PTO. This bonus, called **Prima**, must be at least 25% of the employee's pay in addition to the employee's regular salary. The employer can pay this bonus when the employee takes the leave or in a lump sum at the end of the year.
