End of Service benefits in Saudi according to Saudi Labor law is if the company gives a final exit or terminates and employee contract then as per Saudi Labor Law you're entitled to get half of your monthly for first 5 year and 1 month salary for following years:

How to calculate end of service benefits in KSA?

Labor Education of Saudi Arabia has also provided a Calculator where you can submit the details to get the estimated amount of End of Service benefits in KSA Type of Contract: For "Fixed Time", select any End of Service Reason from the drop-down: Termination of the contract by the employer for one of the terms and conditions stated in Article (80).

What if a Saudi employee works for more than 2 years?

As per the Article 85 of Saudi Labor Law, If an employee stays and works in the company for more than 2 years and less than 5 years. He will be entitled to get 1/3rd of his EOS benefits. EOS Benefits will be half of his Salary in this case.

Who gets a total EOSB Award in Saudi Arabia?

Article 87 of Saudi Labour Law states that the following employees will also get a total EOSB award: A female employee who resigns within 6 months of marriage. A female employee who resigns within 3 months of becoming a mother. An employee who resigns due to a natural disability. In case of death of an employee.
