ESS projects which form part of solar-plus-storage sites, alongside solar projects, can participate in the auction. Any changes to the corporate structure of companies participating in the Macse auction, whether they occur after the deadline for applying to participate or after projects are allocated, must be communicated "promptly" to Terna.

How will MACSE tender targets affect Bess investors?

MACSE tender targets will adapt to the zonal need for storage, but market inefficiencies in predicting fundamental value drivers (e.g., RES buildout, lack of flexibility, interconnection constraints) will likely create locational merchant upside for BESS investors.
