What legislation regulates the procurement of government contracts in Spain?

The procurement of government contracts in Spain is regulated by the following legislation: Royal Decree 3/2020 of 4 February, on urgent measures to transpose into Spanish law several European Union directives in the areas of public procurement in certain sectors - private insurance, pension plans and funds, and taxation and tax litigation.

How much does a public procurement claim cost?

The proceedings relating to a procurement claim before a public procurement court are free of charge. However, if the public procurement court considers that the complainant has acted in bad faith, a penalty of between EUR1,000 and EUR30,000 may be imposed.
