What does the Guam Energy Office do?

The Guam Energy Office, as a line agency within the Executive Branch, implements energy programs for the benefit of the island community using grants awarded by the U.S. Department of Energy - the State Energy Program (SEP) and the Weatherization Assistance Program (WAP).

When will the Guam Energy Office reopen?

The Guam Energy Office will reopen for business starting Monday, June 1, 2020 from 8:00 am to 5:00 pm. Effective June 1, 2020, all GovGuam offices, agencies, and departments will recommence public operations. Continued compliance with Social Distancing rules will be strictly enforced, thus services will be limited to those with appointments only.

Does core tech solar have a legal dispute with Guam Waterworks Authority?

Commissioners did raise some concerns about the award to Core Tech Solar, as affiliate company Core Tech International is currently locked in a multi-million-dollar legal battle with the Guam Waterworks Authority. GPA needs approval from the CCU, before taking the contract awards to the rate-setting Public Utilities Commission for final approval.

Like many U.S. energy producers whose finances were decimated by the collapse, EP gave shares in a newly-constituted company in exchange for eliminating \$4.4 billion of debt. Having emerged from bankruptcy in October 2020, EP said in March it had selected Credit Suisse Group and Jefferies Financial Group to explore a sale of the company.
