

Home energy storage tender price in Spain 2026

How much money will Spain spend on energy storage projects?

Spain's ministry for the ecological transition said on Friday it will allocate EUR 700 million(USD 799.4m) in grants through competitive tendering to support large-scale energy storage projects in an effort to improve grid flexibility and integrate more renewables. Will Spain get 20GW of new energy storage by 2030?

Spain is targeting 20GW of new energy storage by 2030. MITECO also launched a similarly-sized grant scheme specifically for co-located or hybridised energy storage projects,for which proposals were due in March 2023. Enel Green Power submitted two projects during the first quarter which fit the criteria,totalling 60MWh and 38MWh respectively.

What is the Planification of the electricity transmission infrastructure in Spain?

In this context,the renovation of the electricity transmission infrastructure is subject to the Spanish government's planification,which,under the Spanish Electricity Sector Act,operates on a six-year horizon. This planification system is: (i) influenced by political factors; and (ii) unable to address emerging issues promptly.

Why do we need a new electricity system in Spain?

The need to accommodate the increasing integration of renewable energy and the growing demand for electricity, while ensuring the stability of the electricity system, necessitates the renovation of Spain's electricity transmission and distribution infrastructures.

What is happening in Spain in 2035?

These include green hydrogen, biomethane and BESS, among others. Particular attention has been given to the closure of coal-fired power plants. Additionally, the Spanish government has set a target to close all nuclear plants by 2035 and does not currently anticipate the construction of new combined cycle plants.
