What does ENN Energy Holdings Limited do?

ENN Energy Holdings Limited specializes in the distribution of natural gas and energy products. Net sales break down by activity as follows: - construction and installation of gas pipelines (8.7%). The group also operates gas fueling stations for vehicles; - other (2.5%): in particular development of heating and security systems.

Is ENN Energy a good stock for Shanghai-Hong Kong Connect?

ENN Energy is a constituent of the Hang Seng Composite LargeCap Index, the Hang Seng China Enterprises Index and the MSCI China Mid Cap Index. It is an eligible security for Shanghai-Hong Kong Connect and Shenzhen-Hong Kong Connect.

Is Enn a listed company?

The company is incorporated in the Cayman Islands and listed on the Hong Kong Stock Exchange ("HKSE") in 2001 with a market cap of HKD101.6bn as at 21 October 2020. ENN is part of the Hang Seng ESG50 Index and Hang Seng Corporate Sustainability Benchmark Index as of writing.

Who is Enn importing LNG?

ENN has also entered into long term LNG sale and purchase agreements with various suppliers including Chevron USA INC, Origin Energy LNG Portfolio Pty Ltd and Total Gas & Power Asia Private Limited where ENN is obliged to import up to 1.44 million tonnes (~69.2 billion cubic feet) of LNG per year.

What assets are owned by Enn?

Per ENN, assets owned include intermediate, main and branch pipelines, pressure regulating boxes, switches, compressed natural gas ("CNG") trucks and processing stations. ENN may be required to lower down tariff charged to end-users if return on asset ratio is above 7%.

Who owns Kunlun Energy?

In October 2019, PetroChina's 57.6%-owned subsidiary Kunlun Energy announced the acquisition of equity stakes in 17 project companies from Shenzhen-listed Jinhong Holding Group Co., Ltd. ("Jinhong Holding") that are mainly in the gas supply and management business for RMB1.7bn.
