Is Acceleron fusion the only company working on nuclear fusion energy?

Acceleron Fusion is not the only company working on nuclear fusion energy. Several companies across the world have been testing several approaches, including magnetic confinement fusion, inertial confinement fusion, and even other variations of muon-catalyzed fusion.

What is Acceleron fusion technology?

Traditional fusion machines require extreme temperatures of 100 million degrees Celsius. Acceleron's technology uses muons--heavy subatomic particles--to achieve fusion reactions at temperatures below 1,000 degrees Celsius. This approach could speed the transition of fusion from the lab to practical, deployable power plants.

How did Acceleron get funding for a fusion reactor?

The funding follows a major technical milestone achieved by Acceleron in October. The company successfully operated its experimental fusion reactor with highly compressed deuterium-tritium (DT) fuel for 28 continuous hours, following over 100 hours of testing with deuterium.

Is Acceleron backed by a Q1 fund?

Acceleron is backed by the Q1 fund. "Acceleron is paving a path to plasma-free, sub-1000-degree fusion. It's cooler, cheaper, higher-energy gain fusion that stands to turn the industry on its head," said Dr. Clea Kolster, Partner and Head of Science at Lowercarbon Capital.

Why did Acceleron close a \$24 million funding round?

Today, Acceleron announced it has closed a US \$24 million funding round to help develop prototypes of key reactor components and has now completed 100 hours of continuous fusion at its test facility at the Paul Scherrer Institute in Villigen, Switzerland. The experiments are aimed at gathering data rather than producing useful amounts of energy.
