How many gas stations are there in French Polynesia?

Until 2006, our strategy focused essentially on the development and consolidation of our position in French Polynesia, in Tahiti, but also in the outer islands. Leader on the market, our network has 14 gas stations today, in 4 islands (Tahiti, Moorea, Raiatea and Rangiroa).

Does French Polynesia rely on hydrocarbons?

French Polynesia, like most island territories, is highly dependent on hydrocarbon imports. In 2019, 93.8% of energy consumed in the archipelagos came from imports of various petroleum-based fuels. The renewable energy penetration rate in power generation stood at 28.78% in 2019. This figure has remained stable over the last five years.
