

How important are energy thresholds in South Sudan?

appliances for cooling,heating and private transportation (Whiting et al.,2015,UN 2010). These thresholds have been set to meet the UN's goal of universal access to modern form of energy by 2030 and they are important in guiding South Sudan's energy policy.

Is oil the right form of energy for South Sudan?

However,oil is not the right form of energyto meet South Sudan's rising energy demand due to (1) high costs (e.g. high costs of fuel and generator repair),(2) sporadic diesel fuel supply,(3) inefficiency and unsustainability and (4) detrimental health impacts on people and environment.

How does lack of electricity affect business in South Sudan?

Specifically,over 75% of firms surveyed in South Sudan complained that lack of energy hinders business operation. Second,lack of electricity drives up costsas businesses and families try to produce their own power,which is extremely expensive.

Should subsidies be removed for solar & wind energy in South Sudan?

Subsidies have been crucial in the development of any energy sources,including oil and coal in the early stages of development. So,removing subsidies particularly on fuel for generators would level the investment groundfor solar and wind energy in South Sudan.

How do you calculate energy costs in South Sudan?

To determine the costs of energy equipment over time, we converted currencies for which the energy equipment was bought into South Sudan Pound (SSP) using the official exchange rate regime between 2011 and 2017. To convert power KVA to Watts, we used the formula $W = 1000 \cdot kVA \cdot PF$, where PF always equals 0.8.

Why is energy infrastructure underdeveloped in South Sudan?

Partly due to the civil wars(e.g.,1955-1972,1983-2005 &2013-present),energy infrastructure remains very underdeveloped in South Sudan. Despite a peace agreement in 2015,which has been revitalized recently,conflict has impeded the country's effort in transitioning to renewable energy.

On the other hand, the country is rich in natural resources (oil, iron, diamond, copper, nickel, marble, and gold) and has potential hydropower sites. The South Sudan Companies Act of 2012 permits non-South Sudanese to invest in medium and large companies, provided a South Sudanese holds a minimum of 31 percent ownership.

However, the implementation of WTO rules and regulations in South Sudan is still in its early stages. The country has also signed a preferential trade agreement with Sudan, its northern neighbor, in 2012. This agreement grants South Sudan preferential access to the Sudanese market, and vice versa, by reducing tariffs on certain goods.

The situation in South Sudan, the world's newest country, is unique. It does not have any real existing energy infrastructure. The government is roiled by factionalism and corruption, and unable to control large areas of its territory, which is divided into diverging tribal groups and significant parts are difficult to access, creating an effective degree of autonomy.
