Does NGC own a gas pipeline in Trinidad and Tobago?

NGC owns, maintains, and operates most of Trinidad and Tobago's gas pipeline network of approximately 1,000 km, both offshore and onshore.

What role does oil and gas play in Trinidad & Tobago's economy?

The oil and gas sector plays a significant role in Trinidad and Tobago's economy, accounting for 27% of government revenue and 51% of export earnings in 2018. The island nation has a long history of oil and gas production, but has been mainly producing natural gas since the 1990s.

NGC plays a pivotal role in Trinidad and Tobago's gas-based energy sector and is strategically positioned along the entire natural gas value chain.

Where is NGL located in Trinidad & Tobago?

It is engaged in natural gas processing and the aggregation, fractionation, and marketing of natural gas liquids (NGLs), operating as an NGL hub.
