How is EPC tax collected?

The tax is collected largely through the withholding tax mechanism, whereby the project owner withholds income tax of 2.65 - 6 percent from every payment to the EPC contractor. The income tax base commonly is the gross income (contract value). A PE is also subject to Branch Profit Tax of 20 percent referring to the domestic Income Tax Law.
