Will Varo energy buy Preem?

European energy firm Varo Energy is in talks to acquire Preem's two Swedish refineries in a bet on growing demand for low-carbon biofuels, four industry sources told Reuters.

Who owns Varo energy?

It was established as a joint venture between the commodity trader Vitol (75%) and Atlas Invest (25%), a financial holding company owned by the leading energy investor, Marcel van Poecke, who remains the Chairman of VARO Energy.

How will Varo develop hydrogen production hubs?

Hydrogen: leverage position as H₂ consumer to develop hydrogen production hubs. In the initial phase, VARO will invest in an electrolyser at Bayernoil Refinery, with offtake meeting part of the demand from the refinery. Additional green and biogenic production could lead to offtake opportunities for industry, heavy transport and synthetic fuels.
