as Îles Horne). Futuna Island (pop.~5,000); Alofi Island (uninhabited) Alofi Island is the smaller of the two. According to legend it was as densely inhabited as Futuna up until the 19th century, when the Futuna people slaughtered and ate the population in a single raid.

The Futuna island group was discovered by the Dutch in 1616 and Wallis by the British in 1767, but it was the French who declared a protectorate over the islands in 1842, and took official control of them between 1886 and 1888. Notably, Wallis and Futuna was the only French colony to side with the Vichy regime during World War II, a phase that ...
